**OAC 4101:1-4-15-7.1 is the most relevant Ohio provision. It states buildings that store or handle combustible dust must comply with NFPA 61 and NFPA 654.**

**NFPA 70 is covered in OAC 4101:1-27-01.1.**

**Page 17 of Zalosh's report refers to NFPA 496, which I could not find a reference to in the OAC.**

**As with Kilgore's Report, the only other standard is NFPA 499, which I could not find a reference to in the OAC.**

4101:1-4-15.7.1 Combustible dusts, grain processing and storage.

415.7.1 Combustible dusts, grain processing and storage. The provisions of sections 415.7.1.1 through 415.7.1.5 shall apply to buildings in which materials that produce combustible dusts are stored or handled. Buildings that store or handle combustible dusts shall comply with the applicable provisions of **NFPA 61**, **NFPA 120**, **NFPA 484**, **NFPA 654**, **NFPA 655**, **NFPA 664** and **NFPA 85**, and the "International Fire Code".
