



# **Placement Permit - Program requirements Year 2**

There are additional Placement Permit requirements for students entering their second year in the program. Students must meet these requirements in addition to the Year 1 requirements in order to be eligible for Fieldwork Placement. All documents must be shared with Marissa Dean (<a href="mailto:ncrequirements@northern.on.ca">ncrequirements@northern.on.ca</a>) before the deadlines listed below.

## **Year Two Requirements**

### **Medical Requirements**

There are no additional immunizations required for Year 2 of the ECE program. However, students must ensure that their Year 1 immunizations are up-to-date. Notably, TB Skin tests are only valid for one year and must be renewed annually.

### Non-medical requirements

Students with certifications/requirements expiring during the placement period must renew (before expiry) and provide updated documentation to Marissa Dean (ncrequirements@northern.on.ca) to continue to be eligible for placement.
